**5. HB209 Homeschool Amendments (Passed 62 to 13 on 3/5/2025).** Ensures that families no longer need to file an annual affidavit or declare a criminal background to homeschool at the start of the school year. **YES** ★

**6. HB306 Gold-backed Currency (Passed 58 to 6 on 3/7/2025).** Would have allowed the state to invest in gold and created a framework for a digital gold-backed currency. **YES** ★
