3. **SB1459 TikTok Ban (Passed 65 to 29 on 4/12/2023).** Prohibits public employees from using TikTok and other applications on public devices. **YES** ★

4. **SB1405 Internal Revenue Code (Passed 93 to 0 on 4/12/2023).** Would conform Virginia to the Internal Revenue Code ("IRC") on a rolling basis. **YES** ✗
