2. **HR178 United Nations Day** (adopted 96 to 19 on 5/31/2025). Declares October 24, 2025, as United Nations Day in the State of Illinois. **YES** ✗

5. **HB3097 Mandatory Federal Student-aid Applications** (passed 84 to 24 on 4/10/2025). Requires school districts to assist "each high school student" with "education about and the completion of" a Free Application for Federal Student Aid (FAFSA) or, "if applicable, an application for State financial aid." **YES** ✗
